LAKEFRONT RENOVATIONS

The Association has begun renovation projects at the lakefront area. New drains and tiles have been installed on both the center and south end of the area and with the most recent rains worked tremendously well with the water draining from the lakefront and the surrounding properties properly. With a little more time (and less rain) the lakefront area will become more solid with the standing water no longer being an issue.

The new boat launch has been built and is ready to be used. To obtain a key please contact Corky Bell or Larry Cyrier. Remember, to use the facility you must be a member of good standing with the Association meaning that all dues for all properties for which you own and/or reside must be paid to date. The second dues request letters were sent out on May 16, 2011.

The common ground area on the south end has been leveled and with a break in the weather we are going to be planting new grass. After the grass becomes stronger, we are going to be installing a swing set, which was donated by Jolanta and Stanley Nowak.

The beach area has been tilled and leveled. The shoreline has been set back to approximately what it was several years ago with the entire area having a pitch set so that appropriate drainage will occur. The bringing in of used rock material to be placed at the shoreline to prevent future erosion is a possibility and will be discussed in the near future.

The basketball court has been resealed, with some sub-ground drainage set so that in the event of severe rain, most of the water will drain off the court. Lines will be painted on the court with the resetting of the basketball support pole and hoops to be done soon.

More dirt will be needed to complete the leveling of the lakefront property, but due to the high costs of the fill at this time this is being postponed. The fencing will be sprayed to restore its original color and to provide protective sealant to preserve the wood.
